- NO PART OF ANY ORDER WILL BE DELIVERED UNTIL THE BALANCE IS PAID IN FULL.
- THE INTO WISHIN STUDIO RESERVES THE RIGHT TO USE PHOTOGRAPHS FOR DISPLAY, PUBLICATION, OR OTHER PURPOSES.
- IN THE EVENT OF POSTPONEMENT OR CANCELLATION OF THE WEDDING/CONTRACT, THE DEPOSIT PAID IS NON-REFUNDABLE.
- THE STUDIO TAKES UTMOST CARE WITH RESPECT TO EXPOSURE, DEVELOPMENT, AND DELIVERY OF PHOTOGRAPHS. HOWEVER, IN THE EVENT THE STUDIO FAILS TO COMPLY WITH THE TERMS OF THIS CONTRACT, DUE TO ANY EVENT OR ACT OUTSIDE THE CONTROL OF THE STUDIO, THE STUDIO'S LIABILITY IS LIMITED TO REFUND THE DEPOSIT.
- NOTICE OF COPYRIGHT: IT IS ILLEGAL TO COPY OR REPRODUCE THESE PHOTOGRAPHS ELSEWHERE WITHOUT THE PHOTOGRAPHER'S PERMISSION, AND VIOLATORS OF THIS FEDERAL LAW WILL BE SUBJECT TO ITS CIVIL AND CRIMINAL PENALTIES.
